DISPATCH - CARRIER AGREEMENT

This **Dispatch-Carrier Agreement** (hereinafter "Agreement") is made and entered into this [REDACTED] DAY of [REDACTED], 20 [REDACTED], (the "Effective Date"). **BETWEEN:** Rehman Enterprises INC. ("**DISPATCHER**") an individual/Company with its business address located at 3435 Pierce Arrow Circle, Suwanee, GA, 30024, USA.

AND: [REDACTED], ("**CARRIER**") a Registered Motor CARRIER with the FMCSA. MC# [REDACTED], DOT# [REDACTED]; organized and existing under the laws of the state of [REDACTED] with its business address located at [REDACTED];

Collectively referred to as the ("**PARTIES**").

Obligations of Dispatcher:

- The person referred to in this Agreement as "**DISPATCHER**" is in the business of providing loads from freight brokers, freight forwarders, and direct shippers to the carrier (the "**Service**"). Providing load-matching services includes handling paperwork, phone calls and replying emails and text messages to or from the Broker or Shipper to Carrier for the transportation of goods between points and places within the scope of Carrier's operating authority.
- **DISPATCHER** has no financial or legal obligations related to the contract between **SHIPPER** and **CARRIER**.

Obligations of Carrier:

- The **DISPATCHER** has agreed to provide the services in accordance with the terms and conditions in this Agreement. The "**CARRIER**" with the name indicated in this Agreement intends to retain the service of the **DISPATCHER** to perform certain services as contemplated in this agreement.
- **CARRIER** agrees to pay **DISPATCHER** flat fee \$ [REDACTED] OR percentage [REDACTED] % on total weekly gross at the end of every week (Payable at the end of every week on Fridays). In exchange for the services provided under this Agreement and agrees to pay the charges via Debit/Credit Card or by any other payment transferring platforms, unless arranged differently.

NOW, THEREFORE, for and in consideration of the mutual covenants and undertakings herein, and subject to the terms and conditions hereinafter set forth, the **PARTIES** hereto warrant, covenant and agree as follows:

DISPATCH - CARRIER AGREEMENT

LIMITED POWER OF ATTORNEY:

Upon the execution of this Agreement, the **CARRIER** hereby grants a limited Power of Attorney to the Dispatch to act in the capacity of the **CARRIER's DISPATCHER**, and to acquire shipments, negotiate freight rates, and execute paperwork as may be required between Freight Brokers, Freight Forwarders and Direct Shippers. The **DISPATCHER** shall obtain Certificates of Insurance as may be needed to expedite shipments from the **CARRIER** from time to time.

INDEMNIFICATION:

CARRIER hereby agrees to hold **DISPATCHER** harmless and indemnify **DISPATCHER** from any liability arising from any loss or damages to any freight transported by **CARRIER** and agrees to hold the **DISPATCHER** harmless from any claims, personal injury or property damage, which may arise from the operations involved in the transportation of freight.

GOVERNING LAW:

The laws of the state of [REDACTED] shall govern this Agreement, and any dispute arising out of this Agreement shall be resolved in courts of competent jurisdiction in [REDACTED] County.
